# 4. President's report - Kay Söderlund - presented via Skype

Along with maintaining the business of AICCM, National Council has been putting most of its energy into focusing on the future. We continue to operate more broadly than with just standard council positions and work with various sub-committees and Standing committees – allowing members to contribute to AICCM in their areas of interest. This has led to more energy in AICCM that can be directed to 'bigger picture' projects that will allow both the membership and the profession to grow, and develop a higher profile within the community.

During our face-to-face meeting in February we engaged Kim McKay, a PR professional, to talk to us about opportunities for AICCM. While she agreed with many of our ideas, she provided focus and direction – along with sharp observations, insights and suggestions for how we could achieve much more. We were all very energised by Kim's presentation – and we then moved straight into reviewing our Strategic Plan. This has now been released and is on the website, as well as in this presentation. As with any plan, it is a work in progress and we welcome constructive comments and criticism – indeed, we have already had a few since we announced it was on the website.



In May, I attended (along with Alex Ellem and Mary Jo Lelyveld) the AIC meeting in Albuquerque. The reason for this was the theme – 'Outreach and Advocacy' – very much the focus of AICCM also. There were many interesting papers presented and a lot of parallel sessions so it was difficult to attend them all. A few standout presentations were...

- A session that consisted of 5 or 6 short papers outlining different projects that various organisations have instigated to promote and profile conservation.
   These included the 'conservation window' at the Walters Art Museum; the Lunder Conservation Centre and its 'conservation tours'; the Washington Conservation Guild's booth they man at various events; and a recurring Preservation Fair very much along the lines of something being planned for AICCM in November in Canberra more on that later.
- 'Exhibiting Ourselves: Presenting Conservation' was a session that focussed on the presentation of conservators' work in exhibitions and how that can be used to raise the profile of conservation, along with fund-raising potential for their institution. Discussions that followed this session looked at questions posed by the organisers such as 'Does outreach take too much time?'; 'Is the conservation community aware that these exhibits are happening?'; 'It is more valuable to weave conservation information into exhibits on a regular basis rather than having conservation as a stand alone topic?'; 'Do we know what our audience knows about conservation?'; 'Who should take the lead to make conservation more visible? Institutions, AIC, or individuals?'. All very interesting questions and all very relevant to what we have been discussing in Council meetings.

So what are the main things that Council is working on and wanting to bring on board in the next couple of years?

It is probably easiest if we run through the Strategic Plan and I can simply talk about the activities that support those strategies...

#### Establish and Maintain Networks -

- Trialling a number of methods to increase regular communication, such as a Facebook page; shorter and more frequent newsletters; and an email discussion list
- Have identified key organisations in the heritage sector to engage withIn
- Have had a meeting with AIC President, and IIC Vice President, to suggest that IIC assumes a co-ordinating role to allow conservation associations in various countries to work together on international issues, and issues that affect all of us (eg lack of profile)
- Re-established the Education Standing committee to pursue involvement in the tertiary education of conservators in Australia

## Increase and Engage Membership -

- Membership already nearing 700!
- Drawing in more active members to engage in AICCM activities



#### Effective Voice -

- Providing workshops for conservators focusing on lobbying and engagement with government
- Preparing material to assist conservators to represent themselves within their own institution
- Developing profile-raising activities such as the Preservation Fair
- Submissions in 2011/2012 -
  - 1. Process to Refresh the National Research Priorities.
  - 2. National Cultural Policy; and
  - 3. National Heritage Strategy

And here our thanks must go to Mary Jo Lelyveld, Chair of the Blue Sky Group, who has worked tirelessly on pulling all of these submissions together, along with members who contributed thoughts and suggestions. She is the epitome of how AICCM can work more broadly – by engaging members outside of Council who are interested in using their skills on an occasional basis.

#### SIGs and Working Groups -

- Support activities of working groups such as Mould Remediation; and Environmental Guidelines. And a special mention should be made here of the fact that the work of the Environmental Guidelines Working Group won not only the Museums Australia Sustainability Award, but also the overall Museums and Galleries National Awards. Congratulations to Julian Bickersteth, Barbara Reeve, Trish Stokes and Catherine Early in particularly – along with all the other members of the working group.
- Review/simplify budget template for SIG events

#### Improve Financial Base -

- Main focus here is HEART essentially use it as a flagship project and include fundraising activities for other projects
- Successfully applied to GVESHO grant for administrative support (aim is to increase this support to allow engagement of paid Executive Officer)

The two main projects we have on our agenda for 2013 are HEART and the national Preservation Fair day.

HEART, as many of you know, is preparing a network of trained conservators around Australia, that can respond to community needs when disaster has struck. This network will provide a small team to assist museums and communities in establishing their recovery in order to minimalise loss of cultural heritage. This project has the potential to really raise the profile of AICCM and attract serious corporate, government and private sponsorship. We have formed a small committee with representatives from most states that will drive this project forward. One of the first things to happen will be training workshops for conservators delivered around



Australia. I know we talked about this at the last AGM, but these things can take a long time with a volunteer association!

The national Preservation Fair day (putative title) intends to be a major profile raising event for AICCM and the conservation profession. At the moment, we are planning for a pilot day to be run in Canberra around November. In the long term, this will be a national event held on the same day around Australia. Its aim is to have the public bring their items for discussion and assessment by conservators who are manning the stands throughout the day (on a voluntary basis). We will also have various engaging displays, hands-on stations and the like to further educate people about why conservation is important. Susie Collis, Chair of the Special Events Standing Committee is organising this pilot project, with state representatives on the committee. If anyone else is interested in assisting or being involved, please contact Susie or Michelle Berry, our fabulous secretariat.

#### 5. Treasurer's report – Robin Hodgson

This year we see in the detailed Profit & Loss report from the auditor a decrease in profit for AICCM of around \$30,000. This is simply due to the standardizing of the renewal date to coincide with the financial year and to those who made a "large gesture" of paying membership twice for part of this period. We are currently in the mop up stages of membership renewal for this year and in a month or so will be in a position to finalize membership numbers and then make the payments to the state divisions for the capitation fees.

As of this new financial year we have moved banks to Bank MECU where, as a not for profit organization, we receive fee free banking on top of improved rates for our investments. This move will save us around \$1800 in bank fees. The move has also given us the facility to make our payments primarily by EFT using a dual signature system that is easy and efficient. We also have the facility of a debit card for payments that need to be made by card. Also have an investment account to park funds temporally in that we may need during the year but want to earn near term deposit rates on without tying it up for the set period. There is currently \$70k in term deposit. I hope that when we reinvest that in the beginning of next financial year we will be able to increase this toward the +\$100K it has historically been.

We have been fortunate to receive a GVESHO grant for \$5,000 - down from the ~\$9,500 we used to get before we were out of the selection process for 4 years. We are currently in the process of completing the application for next year's grant and will attempt to increase the amount of the grant to go toward the contracting of a part time executive officer.



AICCM is in a sound financial position and is now positioning itself to move forward to take on an exciting new phase for our professional institution, the body that collectively represents our profession and the interests of conservation.
